

CONTINUING LEGAL EDUCATION CREDIT SELF REPORTING ATTENDANCE AND EVALUATION FORM — VIRTUAL FORTY-THIRD NATIONAL HIPAA SUMMIT

The HIPAA Summit is an approved Distance Learning Provider for PA MCLE. As such, the Congress will submit and pay for claimed CLE credits to PA MCLE for attorneys barred in Pennsylvania.
